POSITION PURPOSE

The Program Manager will work in collaboration to fully develop and implement New Day's new substance use services and support staff within the program. The program is designed to support adolescents and young adults who are using substances and their families (chosen and biological). Must be confident in leading groups and coaching others to facilitate therapeutic groups. The program will also create opportunities for community input through a Community Advisory Council (CAC) and community engagement activities. The Program Manager will work with community partners to identify young people who need support and build a strong referral network. This role is a leader within the organization and is responsible for integrating this new program with all existing services and supports. Monitor key outcomes and deliverables.

Employee Relations and Supervision

- Provide regular supervision, evaluation, and support for staff as necessary.

- Ensure staff and participants on the Community Advisory Councill have access to meaningful growth opportunities to enable their best contribution at New Day and advance toward long-term career goals.
- Hold weekly staff meetings to facilitate collaborative opportunities to improve skills and capabilities of staff individually and as a team and review the team's approach to work with young people..
- Co-facilitate groups as necessary to provide feedback and create learning opportunities to support staff with group execution

Management of Program Service Delivery

- Provide input and review all materials created by the staff and the Community Advisory Council to
 ensure they reflect New Day's 10 core values and central approaches and references current literature
 on best practice in substance use support.
- Ensure fidelity to evidenced based models and have ability to track required documentation and data.
- Seek out and develop community partnerships to provide recovery resources for young people who are served.
- Coordinate training opportunities for staff.
- Manage program purchasing within budget expectations.
- Review participation, engagement, and impact from service delivery and participant feedback to determine program efficacy.

- Develop and execute recruitment plan and regularly review participant activity to determine if additional efforts are needed.
- Data monitoring and completion of all funder-required reporting.
- Coordinating and overseeing physical upkeep of meeting and group spaces.
- Work as a team with other staff to ensure consistency, clarity and safety for young people.
- Embody and model for staff, youth and community partners practicing the integration of trauma responsive practice, adolescent development and the Nurtured Heart Approach.
